1. INVITATION FOR BIDS

Sealed tenders are invited for Supply, **Installation and Maintenance of Network based CCTV Surveillance System** at DDCE, Utkal University in two Building of DDCE from the Original Equipment Manufacturers or their authorized channel partners.

The interested vendors are requested to kindly do the site survey for the instant requirement before they present their proposal.

The Tender document along with terms & conditions and specifications/configurations of the above items can be obtained from our website *www. ddceutkal.ac.in* from 24.1.2014 to 07..02.2014.

Last date for Receipt of Tender Paper is 07.02.2014 within office hours.

2. Eligibility Criteria for Bidders

The eligibility criteria for pre-qualification of bidders are as under:

The tenderer(s) should be directly from the Company (OEM) or Authorized channel partner/dealer/distributor of the Company. Its office must be located in Bhubaneswar. In case of authorized channel partner/dealer/distributor, **authorization letter strictly from the manufacturer** must be submitted, failing which the offer will be summarily rejected. The certificate so furnished should clearly incorporate the period for which such authorization is valid and the firm name and address from where after sales services shall be rendered. In absence of such certificate, the Bid is liable to be rejected. All the active components must be from the same OEM.

The bidder should be a registered firm with Sales Tax Authority. The bidder should furnish the registration certificate, TIN No. certificate, VAT registration certificate, PAN No. detail, Audited Balance Sheet and Profit and Loss Statement (amount in Rupees) for last 3 years, Income Tax Returns of last 3 preceding years along with the tender paper. The bidder's firm must be a financially sound having minimum average turnover of more than **FIFTY LAKHS** per annum during last three years In absence of such certificate, the Bid is liable to be rejected.

The bidder should not be black listed in any of the Govt. organization in last 3 years. Undertaking in this regard must be submitted.

3. Two Bid System Tender:

The tender should be submitted in 2 Bid system format i.e 1. Technical Bid & 2. Financial Bid. There should be proper indication of the contents on each envelope.

4. Refundable Earnest Money Deposit (EMD):

All bids must be accompanied by a **bid security of Rs. 50,000/- (Rupees Fifty thousand only)** in the form of Bank Draft / Banker's Cheque drawn from a scheduled bank in favour of "**DIRECTOR, DDCE , Utkal University**", payable at Bhubaneswar

5. Performance Bank Guarantee:

Vendor will have to submit a Performance Bank Guarantee of the value of 20% of the total cost of the Project at the time of receiving Purchase order that must be valid for 24 months on the date of submission.

6. Technical Specifications:

Detailed technical Specifications are as per enclosed **List.** The of items should be latest models and quantity will be decided after through survey by the tenderer.

- 7. Bid Validity: Bids shall be valid for minimum one year from the date of opening of technical bid.
- 8. Costs: The tenderer should clearly indicate specifically the Basic Price, Taxes/Excise duty, other duties (if any), and levies chargeable quantitatively against each item. Prices should be quoted in Indian Currency only. The above mentioned details particularly the Sales Taxes/excise duty, VAT, any other duty, if not quoted properly, the bid can be cancelled. No additional information will be entertained after due date.

The total cost inclusive of all applicable taxes and duties must be clearly mentioned both in figures and words in the price bid, and this will form the basis of price comparison for the award of the tender.

- **9.** Technical Inspection and Performance Evaluation: DDCE, Utkal University reserves its right to carry out a technical inspection and performance evaluation (benchmarking) of the offers made by shortlisted vendors.
- **10. Verification:** DDCE, Utkal University reserves the right to verify any or all statements made by the vendor in the tender document and to inspect the vendor's facilities, if necessary, to establish to its satisfaction about the vendor's capacity to perform the job.

- **11. Shortlisting of Vendors:** DDCE, Utkal University, will create a shortlist technically qualifying vendors and the commercial offers of only these vendors will be opened. DDCE reserves the right to decide whether the equipment's being quoted is as per the requirements and is of standard/leading brands in the market. DDCE, Utkal university reserves the right to decide which offer best suits the requirement of the Campus. Further, after opening Commercial Offers of the short listed Tendered, if there is a discrepancy between word and figures, the amount indicated in words will prevail.
- **12. Warranty/Annual Maintenance:** The vendor shall undertake comprehensive maintenance of the entire CCTV system for TWO years from the date of installation. This would cover the hardware, hardware components, systems software, equipment and accessories supplied by vendor at the place of installation.
- **13. Order Cancellation:** DDCE, Utkal University also reserves the right to cancel the order in the event of one or more of the following circumstances:
 - Delay in initiation of the work beyond 6 weeks from the date of issue of the work order or completion of work beyond a period of 6 weeks from the date accepted as the date of completion of the work.
 - Serious discrepancy in the work being performed/installation being done/hardware or software component noticed during inspection by our experts.
 - Breach by the tenders of any of the terms and conditions of the tender.
 - \circ Any action by the vendor which is in breach of law or accepted practices in the commercial transactions.
 - If the Vendor goes into liquidation voluntarily or otherwise.
- **14. Jurisdiction :**The jurisdiction of the courts shall be Bhubaneswar.
- **15.** DDCE, Utkal University reserves the right to reject any or all tenders without assigning any reason whatsoever.

INSTRUCTION TO BIDDERS

1. Procedure for Submission of Bids:

The offer must be submitted in two sealed cover envelopes separately super scribed as **Part-I** (**Technical Bid**) and **Part-II** (**Price Bid**) in separate sealed envelopes. Both the bids shall be enclosed in another sealed envelope super scribed as: "Installation and Maintenance of CCTV Surveillance System at DDCE, Utkal University" and the address of the firm should be mentioned in the sender side of the envelope with phone number and valid e_mail ID.

Part-I (Technical Bid):

The technical offer should be complete in all respects and contain all information asked for, **except prices**. The Technical offer should include all components asked for in Annexure VI. The suggested items for submission of technical offer is as follows:

- Index
- Covering letter
- The Company profile along with supporting documents
- Details of 3 major projects
- Details of Support Centers
- Warranty Compliance Certificate
- Technical Offer with Specifications . This table should not contain any price information.
- Technical Documentation (Product Brochures, leaflets, manuals etc.)
- The bidder must provide the plan / arrangement, for installation and warranty services to be provided at DDCE, Utkal University
- The detailed technical specifications with Make & Model, Compliance Statement must be as per the technical specifications duly supported by relevant product brochure etc., so as to enable technical assessment of the proposal. Without proper Compliance Statement the bid is liable to be rejected.
- If the technical offer contains any price information the offer will be summarily rejected.

Part- II (Price Bid)

The Price Bid should give all relevant price information as per Annexure VII with proper seal and signature of authorized person. The Bid Form must be filled in completely, without any errors, erasures or alterations. The Price Bid must not contradict the technical bid in any way. Prices should be given in INR in both figures and words.

The total cost inclusive of all applicable taxes and duties must be clearly mentioned both in figures and words in the price bid, and this will form the basis of price comparison for the award of the tender.

Cost of Tender Paper (Non Refundable):

A bank draft of Rs.1000/- in favor of "DIRECTOR, DDCE, Utkal University" payable at Bhubaneswar need to be submitted along with the tender towards the cost of tender document. The tenderer shall bear all costs associated with the preparation and submission of its Bid, including the cost of presentation for the purpose of clarification of the bid, if so desired by the client and the client will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the Tendering process.

Delivery & Installation:

The delivery and installation as per our present requirement must be completed at DDCE, Utkal University (Both in Silver Jubilee Building (3 Floors), Old Administrative Building (2 Floors), PCP Block (2 floors) and around the buildings including Gate area) within 6 - 8 weeks from the date of PO to meet the time lines. However, separate order may be placed for additional quantities on the same rates on "As and When Required" basis within the Bid Validity period as above. DDCE reserves the right to increase or decrease the Bill of Material as per the requirement without any change in the rates quoted, within the bid validity period.

Material must be properly packed against any damage and insured up to the destination. The material should be directly supplied to DDCE, Utkal University . All the expenses involved in transportation etc. shall be borne by the Bidder. All aspects of safe delivery shall be the exclusive responsibility of the Bidder. DDCE will have the right to reject the component/equipment supplied, if it does not comply with the specifications at any point of installation/inspection.

TERMS AND CONDITIONS OF CONTRACT (T&C)

- The company should adhere with all seriousness to the time schedule provided by the DDCE, Utkal University
- The products asked for should be of very high standard and of reputed company with authorized service provider in Bhubaneswar. Mutual trust and nature of services provided should motivate the service provider to give more than what is asked for in the agreement.
- The company should ensure quick back up response in case of equipment failure which should be replaced if needed within 24 hours of the distress call.
- Price Basis: Price quoted should be in the prescribed format. The quoted price will be considered firm and no price escalation will be permitted during the bid validity period.
- **Billing:** Billing is to be done in the name of The Director, DDCE, Utkal University.
- There is no provision for making advance payment to the Company . However, the running bills for the jobs completed can be submitted by the company and will be cleared for payment within reasonable period.
- 80% of invoice value after successful Supply, Installation and, Commissioning of CCTV Surveillance System certified by the concerned Officer of DDCE.

Performance Bank Guarantee (PBG): The successful bidder will be required to furnish the Performance Bank Guarantee from a nationalized bank towards 20% amount of the Bill value.
