Item No. I. Introductory address by the Chairman

The meeting of the Academic Council started with a Welcome Address delivered by the Registrar. The Vice Chancellor in his introductory address emphasized on the glorious past and performance of the University. He gave a brief account of his visit to USA Universities & Institutions as a member of the Delegation of Higher Education under the leadership of Hon'ble Minister of Higher Education, Sri Debi Prasad Mishra and shared with the members his vision for attainment of academic excellence. In his speech, the Vice Chancellor briefed about the recruitment of many new faculty and promotion of the internal faculty and as his further drive to recruit more faculty under USC grant. He also stressed on :

1. Measurement of the performance of the University in term of its products, i.e. in terms of marketability of its students, teachers contribution in research and publications and promotion of extracurricular activities.
2. He emphasized up gradation of University status by next few years
3. Research projects from different funding agencies by the faculty of all disciplines
4. Number of publication in National /International journals
5. The recommendation of the Task Force of Higher Education
Based on his interactions with the Universities and Institutions during his visit to USA, he identified the following areas for collaboration:
 - i) Dual degree in Management
 - ii) Joint programme in Computer Science
 - iii) Health Sciences
 - iv) Faculty and student Exchange Programme
 - v) Collaborative Campus Development
 - vi) Para Health Care Services

Then he highlighted the scope of investment of APT's of Orissa, renewal of academic contacts with our ALLIED in USA. Moreover, based on his interaction with Dr. Sam Pitroda, he proposed for development of a knowledge hub at Utkal University Campus in the form of a knowledge city in a PPP mode, i.e., by sharing its vacant land for the knowledge city.

The Academic Council expressed its satisfaction over the developments and blessed the idea in principle.
