Das, Vice Chancellor, Utkal University to preside over the meeting and he further requested Dr. S.K. Das, Controller of Examinations, Utkal University to assist the Vice Chancellor in conducting the business of the house.

Item No.1 Introductory Address by the Vice Chancellor.

Prof. A.K. Das, Vice Chancellor, Utkal University and Chairman, of the Academic Council his introductory address (Vide Annexure-1) English and Odia version of the Vice Chancellor's Address). The house congratulated Prof. A.K. Das, Vice Chancellor for the road map he set before the House and the University, shared his concerns and hoped that the Utkal University would regain its position of leadership and excellence under his able leadership.

College and consider the regulations of all courses offered in one constituent Law Dept. and two colleges and recommend revisions, to the RAC for its approval and Vice Chancellor's approval thereof. Further Resolved that the faculty members shall prepare a road map for introduction of CBCS for 3yr LLB course w.e.f. 2015-16.

Further resolved that the regulation for 5yr Integrated Law recommended by the RAC be retrospectively applicable from Admission Batch 2009.

No. 24.5 To consider the change of nomenclature of ME in Computer Science & Engineering to M.Tech in Computer Science & Engineering w.e.f. 2013-14.

Resolved that the proposal Board of Studies of Computer Science & Application to change the nomenclature of ME in Computer Science & Engineering to M.Tech in Computer Science & Engineering w.e.f. 2013-14 be approved.

NO. 24.6 To consider the proposal of amendment of Correction Slip. 135 8.3 as follows :

Note –“Ordinary Meeting of the SRC shall be convened by the Chairman of the SRC of the concerned subject on every Second Friday of the month. If the Second Friday fall on holiday the next working day will be the day for meeting of the SRC.

Resolved that the Chairman SRC shall convene ordinarily at least one meeting of the SRC in a month and SRC may also develop fixed schedule as per suitability. Further resolved that the SRCs may be sensitive to the requirement of the scholar and expeditiously process the applications of scholars.

NO. 24.7 To consider the cases for submission of thesis of Ph.D./D.Litt./D.Sc. Scholars who have completed the period of 08 (Eight) years from the date of Registration.

Resolved that those whose registration has lapsed after completion of 8 years or otherwise may apply the Chairman SRC for allowing them to submit the thesis along with the completed copy of the thesis, two publications based on the Doctoral Research with ISSN or ISBN nos., published not earlier than 2 years from the date of submission and application. The SRC may consider such application and allow them to present their pre-submission defense Seminar. The Recommendation of the SRC shall be placed before the Vice Chancellor through Controller of Examinations and in the event Vice chancellor allowing submission of the thesis, the candidate may submit the thesis. Besides usual fees an additional fees of Rs. 5000/- shall be paid by such candidate towards renewal charges.

NO. 24.8

- (1) As per the decision of the Affiliation Committee held on 28.06.2014 it was decided that the colleges which are getting provisional affiliation beyond a stipulated time i.e. 7 years may be informed through an advertisement in the daily newspaper, that affiliation of the colleges will not be extended further, unless the institutions build their own campuses & start operating from that campus.
- (2) It has come to the notice of the University that there is discrepancies about the eligibility criteria for taking admission to various P.G. courses including professional courses i.e. (40% instead of 50% at the Graduation level) under PPP mode course in Govt. Autonomous Colleges securing 50% marks at the graduation level is the University guideline. Therefore, it is proposed to prepare separate certificates which will be issued to the students mentioning the mode of instruction i.e. PPP mode, distance mode & regular mode.
- (3) The University decide not be accord permanent affiliation private professional (Self Financing) colleges at present. The University would like to observe the continuance, stability and viability of such courses for the next few years. Till the matter is cleared by University statutes.

Considered the Report of the Director, DCDC and Resolved that greater co-ordination with Govt. regarding Streamlining of Affiliation process may be considered by the Syndicate and all attempts should be made to dispose of the pending cases.

Further resolved that the representative of Utkal University in various of Bodies (EC/AC/BOS etc.) of the Autonomous Colleges be made aware of their responsibilities.

The Vice Chancellor advised the Academic Councils of Autonomous Colleges to follow the curriculum structures and Broad Regulation of the University and flexibility up to 20% can be allowed to accommodate individual variances.

Resolved that the existing Regulation regarding certificate formats should be followed.

Resolved that the College Development Council may convene regularly Conference of the Principals, Principals and Controller of Examinations of Autonomous Colleges etc.

No. 24.9 To consider the proposal of Chairman P.G. Council for implementation of the CBCS structure w.e.f. 2014-15.

Resolved that the Chairman, P.G. Council shall finalise the detailed syllabus structure and regulation for the 3yr Degree course in Science and Arts (B.Sc. & B.A.) expeditiously in consultation with the P.G. Council members and Teachers of Post Graduate Departments.

Further resolved that the above exercise should be completed by November, 2014 to ensure implementation from 2015-16.

Shri Gouranga Debdas, Registrar, offered a vote of thanks to the Chair and others present. The Vice Chancellor, Chairman of the Academic Council adjourned the meeting to a date to be fixed and notified later.
