### **IMPORTANT INSTRUCTION FOR PRACTICAL EXAMINATION (Regular)**

The Practical Questions for +3 5<sup>th</sup> Semesters (Model/CBCS) Regular Examinations 2024 will be uploaded in UUEMS portal (CBCS) before commencement of the Practical Examinations. Principal/Superintendents are requested to download the questions and conduct the practical examinations.

You further are requested to **conduct the Practical Examinations of +3 5<sup>th</sup> Semester Regular Examination 2024 by inviting External Examiners with minimum three years +3 degree teaching experience, available locally and complete the practical examinations to be held from 03.01.2025 to 11.01.2025.** However, the following instructions may be followed strictly.

1. One Teacher is allowed maximum two colleges as external examiner for conduct of 5<sup>th</sup> Semester Practical Examination. More than two colleges shall not be allowed for conduct of Practical Examination.
2. **Teachers from Self-Financing Colleges, Contractual Lecturers/Guest Lecturers and faculties without teacher code & only +2 teaching teachers cannot be invited as an External Examiner to any institution. No Demonstrator is allowed to be the external.**
